Nebraska Fuel Tax Rate

The third quarter 2018 fuel rate (July 1, 2018 through September 30, 2018) is \$0.28. The rate for the fourth quarter 2018 (October 1, 2018 through December 30, 2018) will be \$0.28.

Unified Carrier Registration (UCR) - 2019 Renewal

Beginning October 1, 2018, UCR is launching its new National Registration System which is moving the UCR filings on-line. The new address beginning October 1st will be www.ucr.gov. Since the UCR renewal is going on-line, we will no longer provide applications. Instead, our office will mail a postcard to all carriers with an active Interstate DOT number reminding it's time to file and will include the website.

The 2019 UCR fees have not been approved as of the printing of this newsletter. Once approved, the postcards will be mailed.

Misleading Solicitations

FMCSA is aware new DOT entrant applicants (carriers) receive confusing or misleading solicitations from service providers or third party vendors by telephone, e-mail, text and US mail. These businesses obtain the carrier information when the application is submitted to FMCSA because the information is publically available.

Aggressive and fraudulent marketing complaints have included carriers being pressured to immediately enroll in drug and alcohol supervisor training, general FMCSA regulatory and compliance support, Unified Carrier Registration (UCR) compliance, biennial update, or Unified Registration System compliance. If you believe you are a victim to fraudulent requests for DOT information and have experienced a loss, report the crime to law enforcement. Report any compromised banking or credit card information to your financial institution or credit card company.

Many service providers and third-party vendors do provide valuable services to the motor carrier community. The carrier's use of these services are at their own option. FMCSA does not endorse private businesses or vendors.

IRP and IFTA Renewal

Be on the lookout for your 2019 IRP and IFTA renewals in the mail at the end of September. The on-line renewal will be available October 1st. New this year is the ability to make changes to your demographic information. All changes will be reviewed by MCS staff before they are final.
