



# INTERNATIONAL FUEL TAX AGREEMENT FOURTH QUARTER 2022 IFTA NEWSLETTER

#### **FOOTNOTES**

### **NEBRASKA FUEL TAX RATE**

The fourth quarter 2022 (October 1,2022 through December 31, 2022) fuel rate is \$0.2480. The rate for the first quarter 2023 (January 1, 2023 through March 31, 2023) will be \$0.29.

## TAX HOLIDAY AND SPLIT RATES

#### **CONNECTICUT**

Connecticut has continued their tax holiday on Gasoline (GA) and Gasohol (GH) through December 31, 2022. If you purchased GA or GH during the fourth quarter 2022 (October 1 through December 31) you will report zero gallons in the Tax Paid Gallons column as you did not pay tax at the pump. The miles travelled in CT will be reported on the CT line, but the gallons purchased for GA and GH will be entered in the "Other" line. Be sure to include the miles and gallons in the totals to reflect an accurate Average Miles per Gallons (AMG).

#### **GEORGIA**

Georgia has continued their tax holiday on all motor fuels through January 10, 2023. The Nebraska fourth quarter return reflects a zero-tax rate for Georgia as the miles are not taxable, nor were taxes paid at the pump. Be sure to include the miles and gallons in your totals and report the miles and gallons on the Georgia line.

## FLORIDA SPLIT RATE - GASOLINE AND GASOHOL

Florida has a split rate for Gasoline (GA) and Gasohol (GH) for the fourth quarter 2022. Travel from October 1st through October 31st the tax rate is zero. Travel from November 1st through December 31st, the rate is .3650.

#### **CONNECTICUT HIGHWAY USE FEE**

Connecticut (CT) has imposed a Highway Use Fee on vehicles registered at 26,000 lbs. and heavier operating on any highway in CT. The fee begins January 1, 2023, and registration is available at <a href="https://portal.ct.gov/DRS-myconneCT">https://portal.ct.gov/DRS-myconneCT</a>. Once registered, a monthly tax return is due regardless if miles were travelled in CT. For more information, contact their office at 860-297-5677, 8:30AM – 4:30PM EST.

## FROM THE AUDIT DESK:

#### PRESERVATION OF UNUSED IFTA DECALS

If you obtain more IFTA decals than are needed during the year, the unused decals **must** be retained for audit purposes. Keep the unused decals for four years, which is the same time requirement for other IFTA records.

It is a good idea (but not required) to inventory the IFTA decals. Keep track of which unit has each IFTA decal as each set of IFTA decals has a unique serial number.
